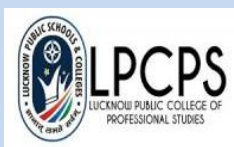

Annual Increment in Salary (Year2020-21)



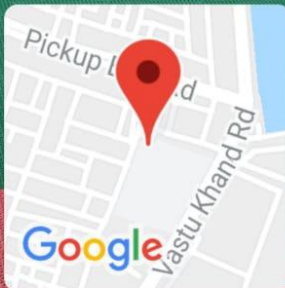
