1. I am to inform you that you have been appointed as Setter and Examiner for paper No. BBA-303 for the BBA Sem V Examination of 2019 in this University.

2. Your appointment is subject to the condition that none of your relation, such as brother, sister, son or daughter, son-in-law or brother-in-law or daughter-in-law as well as their sons and daughters including the husband or the wife of any one of them is a candidate for the examination. The declaration to this effect may be set alongwith your acceptance of the examinership on the enclosed form. In the event of the non-receipt of your acceptance within 12 days it will be presumed that you are not interested in the examinership.

3. Besides the paper setter/examination shall not coach and student privately during the academic year immediately preceding the examination in any subject or any subject or paper for which he has been appointed.

3. The question papers for all the examination in the Faculty of Arts (including B.Ed, M.Ed, B.L.Sc. and Diplomas (Excluding Mathematics and Statistics in the Post-graduate examinations and Languages) B.Sc., B.Com., M.Com. and L.L.B. examinations are to be set both in Hindi and English. For each question English version should follow Hindi version.

4. It is presumed that you are able to set the question paper and also evaluate answer books both in Hindi and English, as Hindi is the medium chosen by the most of the candidate on the undergraduate and postgraduate examinations in the Faculties of Arts, Science, Commerce, Education and Law. The question paper for languages shall be set in the language concerned. You are requested to inform me of your acceptance of the examinership in the enclosed 'Form of acceptance' immediately. An envelope is also enclosed for this purpose. In case you are unable to accept the examinership for any reason, kindly return all the materials sent to you with this letter.

6. You are also requested to send instructions to be followed by the examiner for evaluation purpose on the enclosed sheet.

7. Copies of the syllabus (in the case of External Examiners) and last year's question paper on the subject are enclosed.

8. The following points may kindly be kept in view while setting the paper:
 (i) The name of the examiner should be written in the space provided therefore.
 (ii) The question paper should be very legibly and clearly written in ink or typed on one side of the blank form only by examiner himself proper names and technical terms likely to be found difficult in the manuscript must be written in BLOCK LETTERS in the margin for securing greater accuracy.
 (iii) The marks assigned to each question are to be shown in the margin, and the total number of marks should agree with those prescribed in the regulations for the whole paper of the several parts thereof.
 (iv) The instructions for candidates, if any and the questions set should be clearly worded unambiguous and cover as far as possible the whole course of study.


