

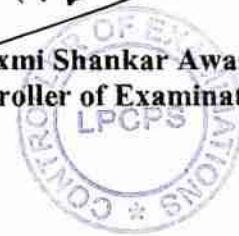

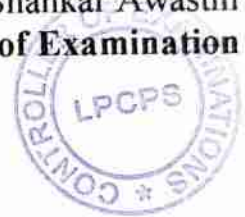

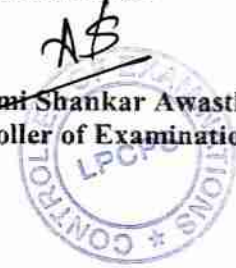

- ii) **Soft News** :- ~~Hard~~ Soft news basically disseminates the information that is not so serious, lesser importance and least worthy for the audience on the common. Soft News is totally performed just for the entertainment purpose and there is not any reporting of serious & issues on problems present in it.
