the paper on time.

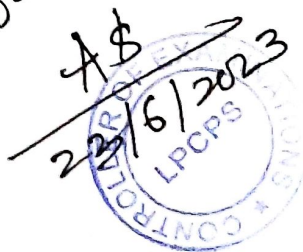

and help me.

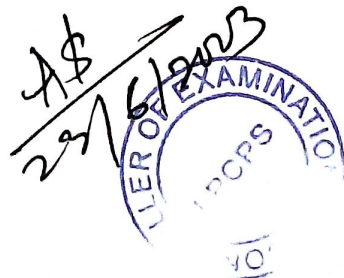

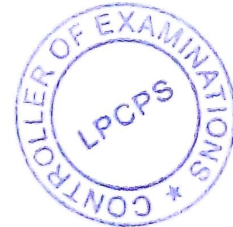
